Services

Deportation Defense Hotline

Call: 1-844-724-3737 (Mon-Fri, 6 AM - 6 PM)

- Provided by Washington Immigrant Solidarity Network (WAISN).
- Statewide, multilingual hotline.
- Reports and tracks ICE/CBP activity.
- Connects you to over 1,400 resources.

Immigrant Safety Plan

- Get help completing a family safety plan to designate caregivers, gather legal documents, and write essential instructions for your child(ren)'s care in case of detention or deportation.
- Special sessions available to train volunteers on how to support families in completing Immigrant Safety Plans.

Legal Consultations and Application Support

- Get expert legal advice and help completing urgent immigration applications.
- Limited, focused legal consultations (up to 2 hours).
- Help filing and reviewing immigration forms.
- Clients must meet eligibility criteria.

Know Your Rights Trainings

- Free community workshops to help immigrants understand their legal rights.
- Know what to do when encountering ICE or law enforcement.
- Most workshops are available in multiple languages.

Information sessions for service providers

- Organized by Northwest Immigrant Rights Project
- Understand the impact of major immigration law and policy changes
- Get insights and service advice from immigration attorneys and policy experts.
